Per your request, Trigg County plans to go with a similar plan as the 2023 General Election with a few changes:

All locations will have print on-demand ballots.

There will be 2 clerks, 2 ballot judges, 1 judge, and 1 Sheriff at the following locations:

East Golden Pond Fire Department, Trigg County Emergency Operations Center,
and The Way. The other locations will have 1 Clerk, 1 ballot judge, 1 judge, and 1 Sheriff.

All precinct officials will have an equal number of Democrat and Republican Officers.

The location of the Drop Box will be in our office at 38 Main Street, Cadiz, KY. The location for Excused Early voting will be held at the Trigg County Clerk's office, same location, May 8-10 and May 13-15, 2024, 8 am to 4 pm.

The location of the 3-day no excuse in-person voting will be at the Trigg County Emergency Operations Center, 39 Jefferson Street, Cadiz, KY 42211, May 16, 17, and 18 from 10 am to 6 pm.

On Election Day, May 21, voters may vote at any one of the following voting centers of their choice:

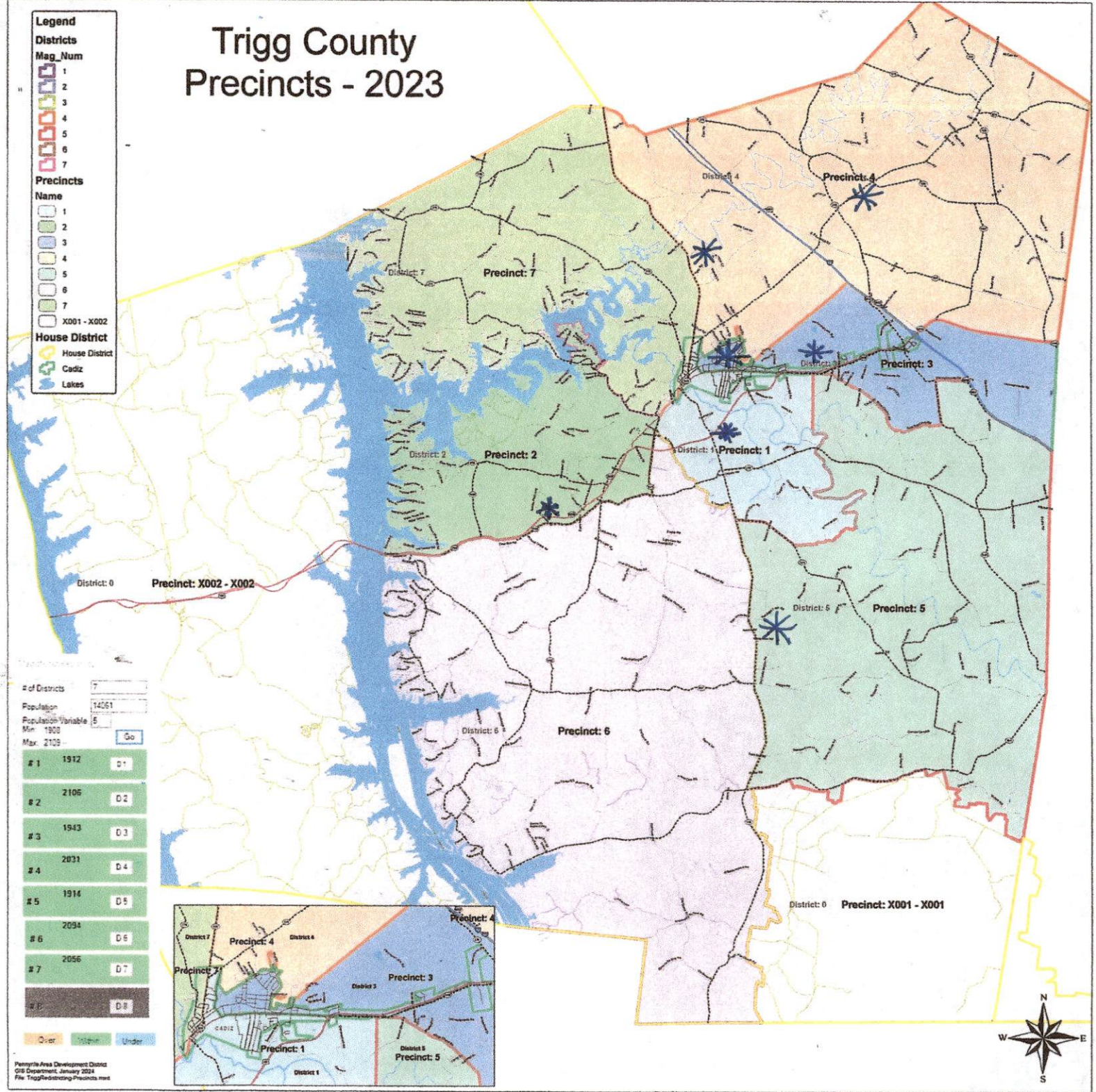
