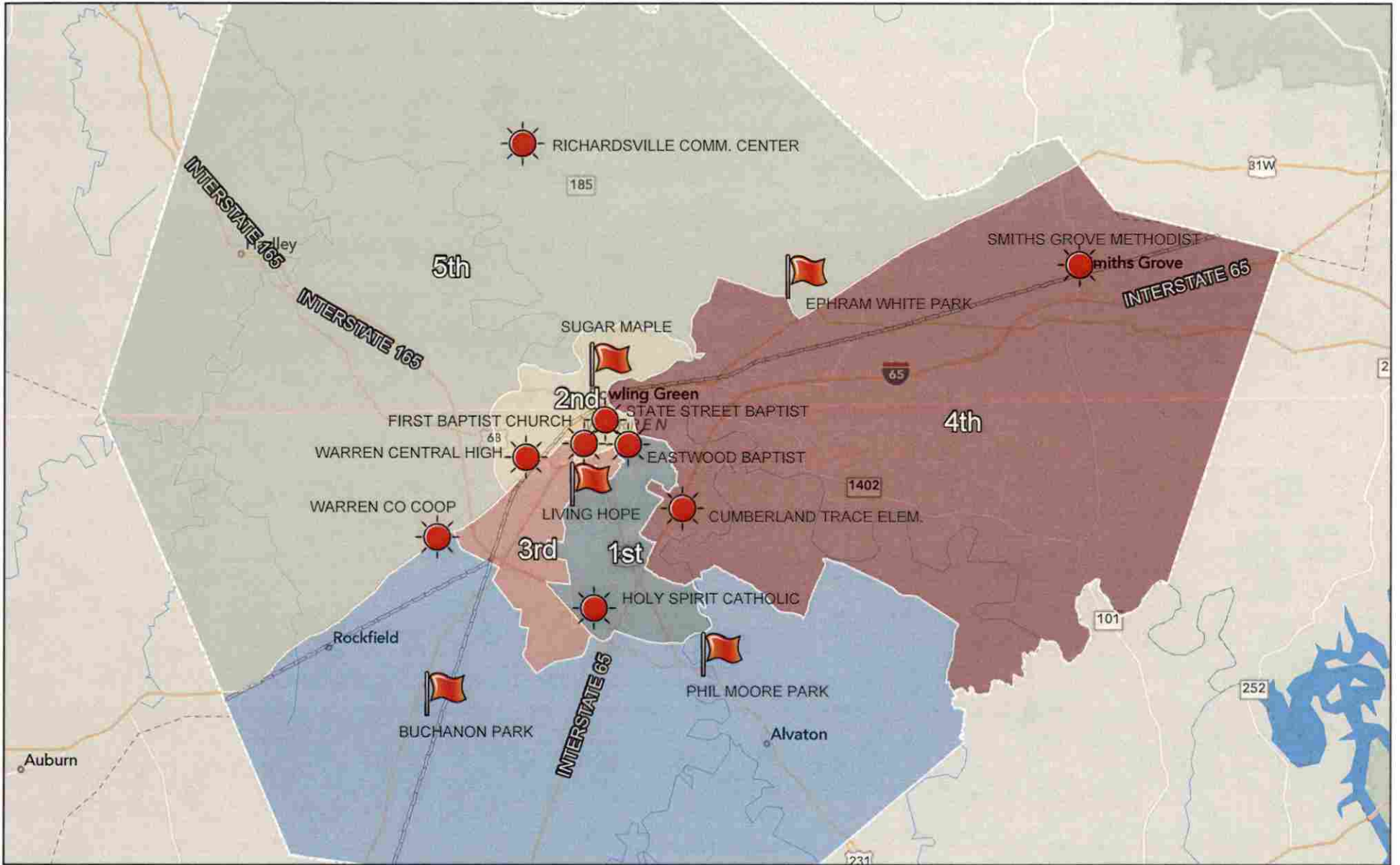

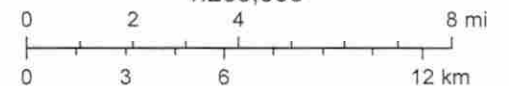

Dear State Board of Elections Members and Staff:

On Tuesday, January 23, 2024 during the regular monthly meeting, the Warren County Board of Elections voted 4-0 to accept the enclosed voting plan for the May 2024 Primary. Warren County plans to utilize the five(5) early vote locations and 12 election day centers used in the November 2023 General Election. Additionally, the board wishes to add two new election day only locations to better serve the county. Both early and election day locations will be countywide vote centers.

Warren County currently has 93,093 registered voters. Using historical data, we have intentionally overestimated a turnout of 35% (approximately 32,583 voters). We used each location's turnout for the last four elections to help determine estimated May 2024 turnout. We are confident all 14 locations will be fully equipped and staffed to handle the maximum number of voters expected at each facility.

Warren County plans to fully transition to Verity Print on Demand for May 2023. Our county will purchase a small percentage of preprinted ballots as backup during this transition. The enclosed spreadsheet outlines our daily allocation of equipment and officers for each location. We will ensure parity among all poll workers across all locations.

Included is a labeled map of locations, and an example of how we set up our countywide vote centers. The board will distribute a mailer to every voter in the county as required by the recent reapportionment. The mailer will provide updated voting precinct information and is expected to go out approximately 45 days

before the primary. In addition, we will continue to produce informational handouts for office staff, candidates, and political parties to distribute. This will be combined with our previous outreach of advertising on social media, the county website, and the Daily News. All information will also be available on our website at warren.countyclerk.us.

Since the change to the vote center model Warren County has been very successful in streamlining the voting process. We have seen shorter wait times around the county and increased our level of customer service for all voters. Our ability to have staff involvement in setting up and running these vote centers has provided a great deal of consistency across all locations. Citizens of Warren County are getting accustomed to the vote center model and the convenience that comes with the ability to vote at any location over a period of four days. We hope legislators see the positive affect vote centers have on our communities and continue to support this model in the future.
